Contract Agreement

THIS AGREEMENT made the 28th day of December 2021 between MUNICIPALITY OF CAPAS of the Philippines (hereinafter called "thei Entity") of the one part and LUCKY SURVEILLANCE SERVICES owned by Mr. Louie Jay I. Garcia with office address at B2 L14 Mary Grace Heights, Purok 6, Dela Paz Norte, City of San Fernando, Pampanga (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., Supply, Delivery and Installation of Closed-Circuit Television (CCTV) at Capas Public Market, and along Mc Arthur Highway, Capas, Tarlac and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two million six hundred seventy-three thousand four hundred fifty-five pesos & 55/100 (Php 2,673,455.75) (hereinafter called "the Contract Price"), in which accomplishment and release of payment shall be in accordance stated herein below;

WITNESSETH:

1. The Contract Price for the Supply, Delivery and Installation of Closed-Circuit Television (CCTV) at Capas Public Market, is in the amount of ONE MILLION TRHREE HUNDRED TWENTY ONE THOUSAND TWO HUNDRED FIFTY EIGHT and 50/100 PESOS (Php1,321,258.50), which shall accomplished as follows:

The Contract Price for the Supply, Delivery and Installation of Closed-Circuit Television (CCTV) at McArthur Highway, Capas, Tarlac, is in the amount of ONE MILLION TRHREE HUNDRED FIFTY TWO THOUSAND ONE HUNDRED NINETY SEVEN and 25/100 PESOS (Php1,352,197.25), which shall accomplished as follows:
