



## **Invitation to Bid for Construction of Rural Health Unit I (Phase IV) at Capas Plazuela, Brgy. Sto. Rosario, Capas, Tarlac**

1. The *Municipality of Capas*, through the *General Fund* intends to apply the sum of *Four million six hundred fifty-six thousand nine hundred seventy pesos (Php 4,656,970.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Construction of Rural Health Unit I (Phase IV) at Capas Plazuela, Brgy. Sto. Rosario, Capas, Tarlac*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Capas* now *Construction of Rural Health Unit I (Phase IV) at Capas Plazuela, Brgy. Sto. Rosario, Capas, Tarlac*. Completion of the Works is required *within fifty (50) days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Municipality of Capas* and inspect the Bidding Documents at the address given below from *8:00 a.m. to 5:00 p.m.*
5. A complete set of Bidding Documents may be acquired by interested bidders on *September 15- October 5, 2022* from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Municipality of Capas* will hold a Pre-Bid Conference on *September 22, 2022, 10:00 a.m.* at *Municipal Hall of Capas*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *October 5, 2022 at 2:00 p.m.* All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *October 5, 2022 at 2:00 p.m.* at *Municipal Hall of Capas*. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Municipality of Capas* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
