### *Invitation to Bid for Installation of Solar Streetlights and Public Address System at Brgy. Sto. Domingo II and Brgy. Sta. Juliana, Capas, Tarlac*

1. The *Municipality of Capas*, through the *General Fund* intends to apply the sum of *One million five hundred thousand pesos (Php 1,500,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Installation of Solar Streetlights and Public Address System at Brgy. Sto. Domingo II and Brgy. Sta. Juliana, Capas, Tarlac*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Capas* now invites bid for *Installation of Solar Streetlights and Public Address System at Brgy. Sto. Domingo II and Brgy. Sta. Juliana, Capas, Tarlac*. Completion of the Works is required *within forty-five (45) days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Municipality of Capas* and inspect the Bidding Documents at the address given below from *8:00 a.m. to 5:00 p.m.*
5. The *Municipality of Capas* will hold Pre-Bid Conference on *June 6, 2024 at 10:00 in the morning* which shall be open only to all interested parties who have purchased the Bidding Documents.
6. A complete set of Bidding Documents may be acquired by interested bidders on *May 30- June 19, 2024* from the address below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *June 19, 2024 at 10:00 a.m.* All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.  
Bid opening shall be on *June 19, 2024 at 10:00 a.m.* at *Municipal Hall of Capas*. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The *Municipality of Capas* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
